

<p>AGREEMENT on Collection and Processing of Personal Data (Hong Kong)</p> <p>This Agreement is entered into between:</p> <p>WIN FOREVER TRUST COMPANY LIMITED, a company registered in the Hong Kong Special Administrative Region of the People's Republic of China, at: HK 168–200 Connaught Road Central, West Tower, Shun Tak Centre, Flat/Rm 3007, 30/F (hereinafter referred to as the “Operator” or the “Company”),</p> <p>and</p> <p>the Individual (hereinafter referred to as the “Data Subject” or “You”), using services related to the opening of a cryptocurrency wallet and custody of Personal Security Assets (PSA) within the framework of cooperation with FINFRESH Microcredit Company LLC and CYBER PAY PAYMENT SERVICES LIMITED.</p> <p>By registering a Personal Account on https://fin-fresh.ru, you perform conclusive actions that signify your full and unconditional acceptance of all terms of this Agreement. Scope of Application</p> <p>This Agreement governs the processing of your personal data by the Operator in connection with:</p> <ul style="list-style-type: none"> - use of the FinFresh.ru and cyberpay.cloud platforms; - registration of a Personal Account; - conclusion of a loan agreement with the Creditor (FINFRESH Microcredit Company LLC); - transfer of PSA to a cryptocurrency wallet managed by the Operator; - performance of obligations under the Agency Agreement and interaction with the Guarantor (CYBER PAY). <p>Visiting the websites, registration, provision of data, or use of services constitutes your voluntary and informed consent to the terms of this Agreement.</p> <p>2. Categories of Personal Data Processed</p> <p>The Operator may collect and process the following categories of data:</p> <p>2.1. Data received from third parties:</p> <ul style="list-style-type: none"> - Credit bureau reports (with your consent); - Data from the Creditor (FINFRESH) regarding loan status, repayment schedule, and Technical Default; - Data from the Agent (Win Forever) on PSA volume, market value, and sale proceeds; - Data from the Guarantor (CYBER PAY) on sale proceeds and debt repayment. <p>Note: The Operator does not verify the accuracy of data provided by you or third parties but relies on its correctness to fulfill obligations.</p> <p>3. Legal Basis for Processing</p> <p>Processing is based on:</p> <ul style="list-style-type: none"> - Your voluntary consent given during registration or contract signing; - Necessity for performance of a contract to which you are a party; - Compliance with legal obligations under Hong Kong law; - Protection of the Operator's legitimate interests in case of default-related risks. <p>5. Data Protection Measures The Operator implements comprehensive safeguards:</p> <ul style="list-style-type: none"> - Technical: industry-standard encryption, two-factor authentication at registration, regular security audits; - Organizational: access controls, staff training, internal compliance policies; - Legal: confidentiality agreements with contractors and partners. <p>9. Governing Law and Dispute Resolution This Agreement is governed by the laws of the Hong Kong Special Administrative Region (PRC). All disputes arising from or in connection with this Agreement shall be resolved by the courts of Hong Kong.</p> <p>10.
